If vehicle is moved out of state, the other state's registration(s) must be provided before proration will be considered.

THERE WILL NOT BE A NEW BILLING OF PERSONAL PROPERTY DUE TO ABATEMENTS / ADJUSTMENTS. PLEASE CONTACT THE TREASURER'S OFFICE FOR THE NEW BALANCE DUE.

SUPPLEMENT# 00 QUALIFIED FOR TAX RELIEF (Y/N)

The Code of Virginia provides tax relief on qualifying personal vehicles. York County Ordinance 05-28 allocates this relief to the first \$20,000 of value and for 2022 this relief results in a 40.5 percent reduction.


